

# TRANSPORTED COOLED SHIPPED SEMEN BREEDING CONTRACT

live foal, subject to the following conditions.

1. The stud fee includes a non-refundable booking fee of \$150.00, payable with this contract. The stud fee balance of \$ \_\_\_\_\_ must be paid before semen is shipped. If resulting foal is born live and can only be issued Breeding Stock Papers and NOT APHA regular registry papers, Double Fee is due back to owner ONLY if Breeding Stallion is **Playboy's Reward**.

2. Stallion owner agrees to ship semen according to the RULES FOR TRANSPORTED SEMEN below.

A. A copy of the mare's registration papers must be included with the signed contract along with a completed SHIPPING INFORMATION FORM.

B. All mares with Impressive breeding must be certified to be N/N.

C. Balance of stud fee, is due before first shipment. Collection/shipping fee is to be paid by mare owner. This is semen collection, preparation and shipping by a licensed Veterinarian. Payment arrangements are to be made with Collection Clinic (Below) before collection and shipment is made:

D. If shipment is lost or delayed, Mare Owner assumes all risks of lost time and expense associated with preparation of his/her mare for breeding.

E. Stallion must be transported to collection facility. Because of this the request for semen must be ordered no less (3) three days prior to insemination.

F. Shipped semen requests will be filled in the order received.

G. Stallion owner will not be held responsible for any time delays or time lost due to transporting stallion to collection facility or for any unforeseen accident or other circumstances that may arise in

shipping or otherwise.

3.) If a mare fails to settle, for any reason, Mare Owner will hold Stallion Owner blameless. Stallion Owner will agree to furnish Mare Owner semen for 2 inseminations per cycle. There will be no more than (2) two total shipments per breeding fee. The Mare Owner has the option to (with stallion owner's approval) substitute another mare during the current season or have a return for the following season.

4.) It is the Stallion Owner's responsibility to provide the Mare Owner with (2) two packages of semen in an industry standard container along with a copy of a letter from the attending reproductive vet attesting to the stallion's fertility.

5.) This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses. If foal is born dead, there are return privileges, as outlined above, for that breeding season only if Stallion Owner is notified within thirty (30) days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal", the mare should miscarry, abort or prove barren, mare owner has the privilege to return her for only the following year

6.) A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when ALL stallion fees and all other expenses have been paid in full; and, when mare has produced a live foal by this mating.

7.) It is further agreed that should the above named stallion die, be sold by owner, or become unfit for service prior to settling the mare, that the Stud Fee less the Booking Fee and Chute Fees will be refunded, if it has been paid in full, however if mare has settled, there shall be NO refund. If mare dies or becomes unfit to breed before being pronounced safe in foal, mare owner may substitute mare, but must be approved by Stallion owner.

8.) This contract is non-assignable and non-transferable.

9.) This contract represents the entire agreement between the parties. No other agreements, promises, verbal or implied, are included unless specifically stated in this written Contract. The original contract will be kept on file at Reese Creek Ranch and a copy provided for the Mare Owner. When Mare Owner and Stallion Owner have signed this Contract, it will then be binding on both parties, subject to the above terms and conditions.
