Mare Care is \$10.00 per day and \$12.50 per day wet (with foal at side). Mare receives alfalfa 2 times daily with turn out once daily. Mare must have negative culture by a veterinarian at owner's expense. We prefer to have culture taken while mare is in heat at the ranch.

Ranch will provide the owner with an invoice for AI mare care charges, stud fees, and other pertinent charges. The invoice is payable upon receipt and prior to the mare's departure, unless alternate arrangements have been made. While the mare and / or foal are boarded at Willow Stage Ranch, the owner/operators shall not be liable for any sickness, disease, theft, death, injury suffered by the horses in their care. All risks are assumed by the mare's owner. The owner agrees to hold the ranch owner/operators harmless and indemnify same against any loss or injury. All costs connected with the boarding are borne by the owner and includes all riding, guests, and invitees of the horse owner.

Emergency Care: If medical care is needed, the ranch owner/operators will attempt to reach the mare owner directly. If the mare owner is not available, the ranch owner/operators exercise best efforts on behalf of the mare owner and have the authority to secure veterinary care on the mare owner's behalf and expense. Owner agrees to pay all said charges.

Right to Lien: The Ranch, and or its operators, has the right to lien for the board amount due and any other costs incurred, and shall have the right to retain horse until indebtedness is paid in full, as set forth by the laws of the State of Oregon.

Mares must arrive at ranch in good condition. They must be well mannered and not pose a threat to Stallion, other horses and or Stallion owners. The mare owner will provide the Ranch Operator with suitable evidence, in Ranch Operator's sole discretion, of mare's registration in owner's name upon arrival to Ranch. Willow Stage Ranch reserves the right to refuse service to mares that are sick, in ill health, or show dangerous behavior. Difficult or problem mares may be referred to Rogue Valley Equine Associates for collection and insemination as mutually agreed to by the parties. Should the parties be unable to reach mutual agreement, this contract shall be void and no fees paid to date shall be refunded.

It is understood that mare proves barren, aborts her foal, or foal is stillborn, (foal unable to stand & nurse within 24 hrs. of birth) a return breeding shall be granted before June 30 of following season with the payment of all booking fees, mare care charges, etc. commensurate with that season's schedule of charges. Written certification by a licensed veterinarian must be provided to ranch that the mare has slipped or produced a non-viable foal. Should mare owner choose not to re-breed the same mare; mare owner may substitute with another mare or sell breeding to an approved mare by stallion owner. There shall be no right of return if owner sells Mare. Should the Stallion die, become injured (unable to breed) or infertile all guarantee's are void and no monies refunded.

All mares shall be checked in foal by a licensed veterinarian prior to departure from the Ranch. Instances where alternative arrangements are mutually made between the parties, the mare owner agrees to deliver to the Ranch evidence from a licensed veterinarian with 30 days of departure that the mare is in foal, or all agreements are void.
